MINISTER OF FOREIGN AFFAIRS OF SINGAPORE DELIVERS KEYNOTE ADDRESS AT EU-ASEAN BUSINESS COUNCIL AGM GALA DINNER AND CALLS FOR DEEPER TRADE AND INVESTMENT RELATIONS BETWEEN EU AND ASEAN

- Singaporean Minister of Foreign Affairs H.E. Dr Vivian Balakrishnan, delivered the key note address following the annual EU-ASEAN Business Council AGM, stressing the importance of building trade and investment relations through Singapore's ongoing Smart Nation Initiative.
- EU-ABC elected a new board and announced plans to hold a major ASEAN-EU Business Summit in Singapore in 2018, the year in which Singapore will next serve as Chair country of ASEAN

Singapore, 28th June 2017– H.E. Dr Vivian Balakrishnan, Minister of Foreign Affairs of Singapore and Minister-in-Charge of the Smart Nation Initiative of Singapore, called for forging ever closer commercial and investment ties between the people of the EU and Southeast Asia in his capacity as the honorary guest and keynote speaker at the EU-ASEAN Business Council's AGM Gala Dinner last night.

"This year marks the 50th anniversary of the establishment of ASEAN, and the 40th anniversary of ASEAN–EU dialogue relations. While some parts of the world continue to face challenges in pursuing free and open trade and investment, ASEAN and the EU on the other hand have stood firm in our commitment to bring about development, prosperity, and benefits for our businesses and our people through regional integration. It is critical therefore that we succeed, because the proof of the pudding is in the eating. In this regard, I would like to take the opportunity to express my appreciation for the work done by the EU-ASEAN Business Council," said H.E. Dr Balakrishnan.

The EU-ASEAN Business Council (EU-ABC) is the primary voice for European business within the ASEAN region. The Council works on a sectorial and cross-industry basis to help improve the investment and trading conditions for European Businesses in the ASEAN region through influencing policy and decision makers throughout the region and in the EU, as well as acting as a platform for the exchange of information and ideas amongst its members and regional players within the ASEAN region.

Speaking at the AGM Dinner, EU-ABC Chairman Donald Kanak said, "We are companies with long traditions, and immense passion for the region and its people. We view ourselves as part of the ASEAN family. The region's success will be our success. I am confident that for European businesses operating in Southeast Asia, there is a bright future of more growth, more employment, and more investment, leading to more prosperity in the countries and communities in which we work."

He noted that European business remains committed to the ASEAN region, as shown by the 2016 ASEAN-EU Business Sentiment Survey where an overwhelming majority of European companies reported that they expected to increase trade and investment in the region. The EUABC plans to repeat the survey in Q4 2017.



Mr Kanak continued: "We plan further studies and publications regarding trade and investment issues in the automotive industry, healthcare, the Digital Economy and IPR/Illicit Trade issues expected before the year end," he added.

The EU-ASEAN Business Council Gala Dinner was also honoured by the presence of the EU Ambassador to ASEAN (H.E. Francisco Fontan Pardo), the EU Ambassador to Singapore (H.E. Dr Michael Pulch), several European Ambassadors and ASEAN Ambassadors to Singapore and members of the Diplomatic Corps following the Annual General Meeting. Mr. Donald Kanak, Chairman, EU-ASEAN Business Council; Chairman, Eastspring Investments

Don Kanak is the Chairman of Eastspring Investments, the Asia investment organisation of Prudential plc, which is one of Asia's leading retail asset managers with US\$146 billion in assets under management (as at 31 December 2016). Don is also Chairman of Prudence Foundation Ltd., the community engagement arm of Prudential in Asia.

Mr. Kanak is based in Hong Kong and has lived and worked in Asia for over

28 years. From 2008 to January 2016, he served as Chairman of Prudential Corporation Asia, and from 1992 to January 2006, he served in a number of senior positions at American International Group (AIG), ultimately as Executive Vice Chairman and Chief Operating Officer of AIG.

In 2011-12, Mr. Kanak chaired the World Economic Forum's Global Agenda Council on Insurance and Asset Management and is currently a member of its Council on Southeast Asia. He is also a member of the Council on Foreign Relations.



Mr. Kanak is a Senior Fellow of the Harvard Law School Program on International Financial Systems. He is a Trustee of WWF-Hong Kong, and serves on the National Council of WWF-U.S.

He holds a J.D. with honours from Harvard Law School and an M.Litt in Management Studies from University of Oxford (U.K.), and a B.A. with highest honors in economics from the University of North Carolina-Chapel Hill, and currently chairs the UNC Global Leadership Council.

Mr. Bakker graduated from Leiden University in the Netherlands, is admitted to the Amsterdam bar and is a registered Foreign Lawyer under the Indonesian Advocates Law. He has worked in Indonesia since 1984, over time building up extensive experience in foreign direct investment, project finance, including private power, aircraft finance, infrastructure development and general manufacturing investment. During the Asian financial crisis, he became involved in many aspects of restructuring and insolvency and has advised on foreign law issues of bankruptcy reform in Indonesia. His practice now also encompasses structured finance and mergers and acquisitions. He is an international commercial arbitrator registered at the National Indonesian Arbitration Institute and the Singapore International Arbitration Centre. He is a Fellow at the Chartered Institute of Arbitrators.

Mr. Bakker is on the Supervisory Board of the Indonesia Netherlands Association and a member of the Executive Board of EuroCham Indonesia. He has published various articles on insolvency and cross-border investment issues and teaches at the Faculty of Law of University of Indonesia and at the Indonesian Ministry of Law and Human Rights.



Mr. Martin Hayes, MNC Representative, EU-ASEAN Business Council, President, Robert Bosch SEA & Managing Director, Robert Bosch Singapore

Martin Hayes has been the president of Bosch for Southeast Asia, as well as the managing director of Bosch for Singapore since 1 January 2011. Up until October 2014, he was also the managing director of Bosch in Malaysia. Based in Singapore, Mr. Hayes is responsible for driving the Bosch business in the region.

Mr. Hayes was formerly Executive Vice President at Bosch Automotive Thailand Co. Ltd, Rayong, Thailand, responsible for automotive Original Equipment (OE) sales to customers in Southeast Asia and Australia. He was also a director of the Board since January 2006. He was instrumental in setting up the sales organisation across the region and for developing sales growth with OE manufacturers.



Born in Hornsea, the United Kingdom, Mr. Hayes went on to study Electrical and Electronic Engineering at Portsmouth University, where he obtained a 1st class honours degree.

Mr. Hayes joined the Bosch Group in Germany in August 1987 after his stints at Marconi Underwater Water Systems Ltd as a design engineer, and Factron Schlumberger as a manager for test and development. Since then, he has amassed a wealth of international management and leadership experience in several functions, including global responsibilities. Over the past 25 years, he has worked in Germany, the United Kingdom, and Thailand before arriving in Singapore.

Presently, Mr. Hayes is vice chairman of the EU-ASEAN Business Council, of which he is one of the founding members; a board member of the Singapore International Chamber of Commerce (SICC) and chairman of the chamber's ASEAN committee; as well as a board member of the Singapore-German Chamber of Industry and Commerce (SGC) and chairman of its Automotive Committee Roundtable. He is also an active contributor to the Centaur Group of Senior Management Leadership Program, which is affiliated with the Cranfield University, UK. Mr. Hayes is a certified member of the Institution of Engineering and Technology, UK (IET).

Since assuming the role as president of Bosch for Southeast Asia, Mr. Hayes has been speaking at numerous conferences and high-profile events such as the <u>fourth Kuala Lumpur International</u> <u>Automotive Conference</u>, the <u>FT-Nielsen ASEAN Cities Summit 2015</u>, the <u>ASEAN and AEC 2015</u> conference in Berlin, and chairing the annual <u>ASEAN-EU Summit</u>.
