EU-ASEAN BUSINESS COUNCIL BRINGS TRADE & INVESTMENT MISSION TO MALAYSIA

MEETINGS TO BE HELD WITH VARIOUS GOVERNMENT MINISTRIES AND SENIOR POLICITIANS

EU-ABC CALLS CLOSER TRADE AND INVESTMENT TIES BETWEEN MALAYSIA AND EUROPE AND SEEKS SUPPORT FOR FASTER PROGRESS ON ASEAN ECONOMIC INTEGRATION

- EU-ASEAN Business Council brings a delegation of more than 20 large European businesses to Malaysia
- EU-ABC seeks updates on the trade and investment climate in Malaysia and closer trade ties between the European Union and Malaysia
- EU-ABC also seeks the support of Malaysia in advancing ASEAN economic integration.

Kuala Lumpur, 18th **March 2019** – The EU-ASEAN Business Council, the leading regional body for European Businesses in South East Asia, today begun a trade and investment trip to Malaysia, bringing more than 20 European companies for meetings with the Malaysian Government and leading politicians.

Commenting on the mission, EU-ABC Chairman and head of delegation, Mr Donald Kanak, said: "Malaysia is one of the leading economies in Southeast Asia and a key trading and investment partner in ASEAN for Europe. We are here to promote further improvements in that trade and investment relationship and to have discussions with the Malaysian government on a wide range of topics to enhance the understanding between government and industry".

He went on to say, "Clearly this is a very strong trade and investment relationship and one that we hope will continue to grow. Trade in goods between the EU and Malaysia has grown by more than 34% over the last 10 years with the balance of trade being very much in Malaysia's favour. Malaysia is the EU's third largest trading partner in ASEAN and also the 3rd largest recipient of EU FDI at US\$2.4bn in 2017, which was a more than 70% increase over 2016."

Chris Humphrey, Executive Director of the EU-ABC, said: "Part of our mission will also be to discuss moves to speed up ASEAN economic integration. Malaysia is a key and leading player in the region and has been a strong proponent of closer economic integration in Southeast Asia. It is clear to us that moving quicker on this project will only benefit the economies of ASEAN and help increase their attractiveness to more trade and investment from the EU."

He also noted that European business remains committed to the ASEAN region, as shown by the 2018 ASEAN-EU Business Sentiment Survey where an overwhelming majority of European companies reported that they expected to increase trade and investment in the region. The EUABC plans to repeat the survey in 2019, with the survey results to be released in September 2019.
