Malaysia has much to offer as an investment destination, and there is work to be done at the Council to push for FTA negotiations to resume.

As if two health events are not enough, the Health lead of the Council managed to squeeze one last event on the final week of September on the Life Course Immunisation Ideation Initiative that the Council partnered with Asian Development Bank and Sanofi.
